CALL TO ORDER, QUORUM DETERMINED, MEETING DECLARED OPEN, RECOGNITION OF GUESTS, INVOCATION

Mrs. Bates called the meeting to order at 11:34 a.m., declared a quorum present, meeting declared open.

DISCUSS AND CONSIDER APPROVAL OF THE FOLLOWING MINUTES

Motion was made by Dr. Hambrick and seconded by Mr. Bandemir to approve the Regular Scheduled Meeting Minutes of November 8, 2022. Motion was approved unanimously.

DISCUSS AND CONSIDER APPROVAL OF THE FOLLOWING FINANCIAL REPORTS

Mr. Sharp presented the Balance Sheet, Budget Report, and Commitments for the months ending October 31, 2022 and reported the following:

• Cash – SEDCO Checking: \$4,575,213.95

• Accounts Payable: \$34,117.78

• Fund Balance: \$16,288,563.45

• Revenues Over/Under Expenses: \$484,814.23

• Total Liabilities, Equity and Current Surplus (Deficit): \$16,807,495.46

Revenue Total: 8.87 %Expense Total: 1.76 %

Motion was made by Mr. Bandemir and seconded by Mr. Brumm to approve the financial reports for the month ending October 31, 2022. Motion was approved unanimously.

SALES TAX AND ECONOMIC BAROMETER REPORTS

Mr. Sharp reported a 12.82 % sales tax for the month of December.

Ms. Bellows presented the November 2022 Economic Barometer Report and reported the following:

- New residential permits saw a 21% decrease compared to November 2021, but the YTD was up 48%. There was one new multi-family permit for the Stone Creek Apartments on FM 1417.
- Commercial and industrial permits were up approx. 67% from this time last year and up 28% on the YTD. The most notable of these were permits for the construction of the Courtyard Marriott valued at \$6.6M, a new concession stand at Sherman High School valued at \$1.35M, and a new O'Reillys valued at \$1M.
- The city was up 432 customers compared to November 2021 and up 12 customers from October.
- November's sales tax saw a 16.26% increase from November 2021, and the YTD was up 15.38%.
- In October, Grayson County's months' supply of housing inventory was 3.9 months, up from 3.5 months in September.

Sherman's October unemployment rate remained at 3.4%.
