CALL TO ORDER, QUORUM DETERMINED, MEETING DECLARED OPEN, RECOGNITION OF GUESTS AND VISITORS

Mr. Kirkpatrick, Chairman of the Sherman Economic Development Corporation, called the meeting to order at 7:34 A.M., declared a quorum present, meeting declared open, recognition of guests and visitors.

CONSIDER FOR APPROVAL THE MINUTES FOR THE FOLLOWING MEETINGS

Motion was made by Mr. Sild and seconded by Mr. Douglass to approve the regular scheduled meeting minutes of June 13, 2017. Motion was approved unanimously.

FINANCIALS

Mrs. Davis presented the Financials for the quarter ended June 30, 2017 and reported the Ending Fund Balance as \$8,582,571. She also referred to the Incentive Schedule and noted the \$9,839,293 in outstanding commitments.

Mrs. Davis also presented the Investment Report for the quarter ended June 30, 2017 and reported the Book Value as \$6,760,185 and the Weighted Average Yield as 0.87%.

Motion to approve the Financials and the Investment Report for the quarter ended June 30, 2017 was made Mr. Shields and seconded by Mr. Willie Steele. Motion was approved unanimously.

EXECUTIVE SESSION

The Sherman Economic Development Corporation held an Executive Session pursuant to the provisions of the Open Meetings Law, Chapter 551, Government Code, Vernon's Texas Codes Annotated, in accordance with the authority contained in the following section:

Section 551.087 – Economic Development: Discussion concerning the following Projects: Bear, Tackleberry, Overland, Aurora, Lynn, Red Oriole, Homecoming, Red, Cake, Carrot Flower, Green, Post Oak, Laminate, Glass, Synergy

Section 551.072 - Real Property: Discussion concerning projects: Box, Future, House, Northgate Drive, Truck

The open meeting recessed in executive session at 7:39 a.m. Before discussions regarding Project Synergy took place, Mr. Kirkpatrick signed the Conflict of Interest form and excused himself from executive session.

RECONVENE OPEN MEETING AND CONSIDER ITEMS DISCUSSED IN EXECUTIVE SESSION

After the discussions regarding Project Synergy were complete, Mr. Kirkpatrick returned for the remainder of the executive session and reconvened the open meeting at 8:10 a.m.

Mrs. Jones recommended the approval of a Sherman Economic Development Corporation Economic Development Performance Agreement with CertainTeed Corporation. The agreement states that CertainTeed will invest \$50,000 and add an additional 10 full-time jobs at is facility at 1400 FM 1417 W, and SEDCO will provide an incentive of \$50,000 upon proof that the conditions have been met.

Motion to approve the Economic Development Performance Agreement with CertainTeed Corporation was made by Mr. Shields and seconded by Mr. Willie Steele. Motion was approved unanimously.

Mr. Gadek recommended the approval of a Sherman Economic Development Corporation Economic Development Performance Agreement with Synergy Windows and Doors, LLC. The agreement states that Synergy will invest \$600,000 and add an additional 18 full-time jobs at its facility at 2909 Fallon Drive, and SEDCO will provide an incentive of \$54,000 upon proof that the conditions have been met.

Motion to approve the Economic Development Performance Agreement with Synergy Windows and Doors, LLC was made by Mr. Douglass and seconded by Mr. Willie Steele. Motion was approved by Mr. Sild, Mr. Douglass, Mr. Shields, and Mr. Willie Steele. Mr. Kirkpatrick abstained.

ECONOMIC BAROMETER REPORT (July 2017)

Mr. Gadek presented the Economic Barometer Report and noted the following: New residential city building permits are up 81.25% from YTD 2016; total city building permits value is up 92.89% from YTD 2016; SEDCO's sales tax proceeds are down -2.99% from YTD 2016; and Sherman's unemployment rate is 3.9%.

PRESIDENT'S REPORT (August 2017)

Mr. Plotnik noted the FY 2016-2017 Completed Projects and Signed Agreements in the board packet and presented the following August 2017 President's Report:

Project Information

SEDCO is presently working 17 active projects with an estimated \$1.5 billion in investments and 1,205 new jobs.

SEDCO Operations/Administration

We are preparing for our annual joint meeting with the City Council to approve the 2017-2018 Budget and Program of Work. Our proposal to the City Council includes a continuation of our workforce development efforts to increase the employee base and marketing this great city to national and international markets through new and unique advertising opportunities. SEDCO continues to present Sherman with a positive, business attitude, surplus water, available sites, and low utility costs. As a result, we are no longer considered that "little fishing village at Lake Texoma." Now, many are seeing us as the next expanding market for business and job creation. The following report highlights those activities we are developing for the benefit of the Sherman community.

On July 17th, the staff met with CBS News Radio KRLD to discuss potential radio advertisements to target site selectors in the DFW metroplex over the next fiscal year.

On July 18th, we hosted our Summer Leadership Breakfast with 19 industry representatives and community leaders in attendance. This quarterly event includes a round table discussion on the wants, needs and desires of multiple Sherman industries.

On August 4th, SEDCO sponsored a table at the Sherman Chamber New Teacher Luncheon. This special event is a SEDCO favorite, because we enjoy meeting and supporting the new SISD teachers. It's also a great opportunity for us to share about the Advanced Manufacturing Program and the Industrial Maintenance Technology Program and the opportunities available to our teachers to get involved in Business Education for Teachers.

Business Recruitment

Since our last report, SEDCO hosted nine visits from site selectors and real estate professionals. We also had six projects visit Sherman.

We're now receiving great feedback from our last marketing mailer campaign, "The Future is Looking Good," which included a pair of sunglasses with the SEDCO and Sherman Chamber of Commerce logos. Our next advertisement in the Dallas Business Journal will be published on August 11th in the Commercial Real Estate issue.

Business Retention/Expansion Program

Our ongoing program will not only move toward increased relationships with our corporate citizens but is also a valuable resource for referrals within their respective industries.
