CALL TO ORDER, QUORUM DETERMINED, MEETING DECLARED OPEN, RECOGNITION OF **GUESTS AND VISITORS**

Mr. Kirkpatrick, Chairman of the Sherman Economic Development Corporation, called the meeting to order at 7:30 A.M., declared a quorum present, meeting declared open, recognition of guests and visitors.

CONSIDER FOR APPROVAL THE MINUTES FOR THE FOLLOWING MEETING

Motion was made by Mr. Sild and seconded by Mr. Douglass to approve the meeting minutes of the September 15, 2016 Annual Joint Meeting of the Board of Directors and the Sherman City Council and the regular scheduled meeting minutes of October 11, 2016. Motion was approved unanimously.

SEDCO FINANCIALS AND INVESTMENT REPORT

Mrs. Lawrence presented an overview of the Sherman Economic Development Corporation Financials and presented the Investment Report for the quarter ended September 30, 2016. She also noted that the Incentive Schedule was tracking as expected. Motion to approve was made by Mr. Douglass and seconded by Mr. Shields, Motion was approved unanimously.

EXECUTIVE SESSION

The Sherman Economic Development Corporation held an Executive Session pursuant to the provisions of the Open Meetings Law, Chapter 551, Government Code, Vernon's Texas Codes Annotated, in accordance with the authority contained in the following section:

RECONVENE OPEN MEETING AND CONSIDER ITEMS DISCUSSED IN EXECUTIVE SESSION Mr. Kirkpatrick reconvened the open meeting at 8:09 A.M.

Mr. Plotnik recommended that Sherman Economic Development Corporation assist with a Box Culvert on Progress Drive to support Project Box.

Motion to approve up to \$150,000 to make necessary improvements to the culvert on Progress Drive as presented was made by Mr. John Sild and seconded by Mr. Brad Douglass. Motion was approved unanimously.

Mr. Plotnik recommended an Addendum to the Sherman Economic Development Corporation Economic Development Performance Agreement with 903 Brewers to amend section 2.1 of the Agreement to extend the Schedule A Time of Performance from the original equipment installation ending date of December 8, 2016 to May 8, 2017.

Motion to approve the Addendum to Economic Development Performance Agreement with 903 Brewers was made by Mr. Douglass and seconded by Mr. Tom Shields. Motion to approve was unanimously.

Mr. Plotnik recommended approval of the easement contribution to the City of Sherman for Project Northgate. The final replat supports the City of Sherman work to extend to West Travis.

Motion to approve the recommendation as presented was made by Mr. John Sild and seconded by Mr. Tom Shields. Motion was approved unanimously.

ECONOMIC BAROMETER REPORT (October 2016)

Mr. Gadek referred to the EBR report in the board packet and noted that permitting for single family dwellings was lagging slightly. He also pointed out the slight increase in Sherman's Unemployment Rate (from 3.7% to 3.8%), and that Sherman's sales tax proceeds were up 12.43% for the calendar year.

NTRA MANAGEMENT UPDATE

Mr. Plotnik discussed the North Texas Regional Airport Management Update for October 2016. Sarah Hinton was named the Director in August.

SEDCO is presently working 19 active projects with an estimated \$1,827,900,000 in investments and 3,287 new jobs.

SEDCO Operations/Administration

On October 11th, the SEDCO Board of Directors elected Mr. Greg Kirkpatrick as Chairman, Mr. John Sild as Vice-Chairman, and Mr. Brad Douglass as Board Secretary for the fiscal year 2016-2017. Mr. Willie Steele and Mr. Tom Shields will continue as Board Members.

SEDCO plans to strategically place advertisements that highlight Sherman's attributes within key issues throughout the next year. Business Recruitment

John Plotnik attended the Society of Industrial and Office Realtors (SIOR) Fall World Conference in New York and spoke to over 150 site selectors about the advantages of introducing their clients to site availability and incentives in the City of Sherman. As each site selector closes an average of 10 projects per year, John was potentially in front of 1,500 companies.

Frank Gadek attended the Industrial Asset Management Council's (IAMC) Professional Forum in Indiana. This event is held twice a year and provides several opportunities to share knowledge and network with other economic development professionals. At this forum, SEDCO participated as a host of the Texas Dinner, which was a special event that included about 20 site selectors.

This past month, we mailed a marketing piece to each of the 127 site selectors within the North Texas Chapter of the SIOR, we met with about 50 site selectors, and hosted two project site visits in Sherman.
